- ✓ font - Times New Roman, 14;
- ✓ line spacing - 1.5;
- ✓ margins: top, bottom, right, left - 20 mm; paragraph indentation - 1.25 cm;
- ✓ references to the sources used should be made in the text in square brackets;
- ✓ the list of references is given at the end of abstracts in the order of mentioning sources in accordance with the National Standard of Ukraine "Bibliographic reference" (DSTU 8302: 2015).
